# Avoiding a Deficit

### -Allocated National Tax will Decrease by ¥2.5 Billion-

#### Minamiboso's Finances are Highly Dependent on Allocated Taxes


As seen in the 2013 Minamiboso Financial Report, of the total yearly revenue of ¥25.2 billion, ¥10.1 billion (40%) was provided by national tax revenues allocated to the city. In other words, Minamiboso is financially dependent on

these allocated taxes. In comparison, city taxes only produced ¥3.9 billion, or about16% of total revenue.

#### The Tax Allocation System

In essence, the various services provided by local governments must be paid for by taxes from the citizens. However, due to varying degrees of urbanization and success of business enterprises, some local governments are more fortunate in terms of tax revenue than others. The tax allocation system levels out this disparity by guaranteeing that everyone will be able to receive a certain level of government-provided services no matter where in Japan they live.

Municipalities with insufficient tax revenues, like Minamiboso, receive a great deal of allocated tax.



#### Minamiboso is Getting Extra Funding because of its Merger

Minamiboso City was formed in 2005 when 7 villages merged together. When villages merge this way, the numbers of public facilities and public workers ordinarily decrease, which in turn reduces administrative costs. As a result, allocated tax revenues are also cut.


However, if administrative reform is done all at once, it is possible that the services provided to residents may be harmed. Taking this in to consideration, a special exception called the "Town Merger Compensation" has been established. This allows the individual administrative systems of merged towns and villages to remain for 15 years after the fiscal year following the merger (from 2006 to 2020 for Minamiboso) without the allocated national tax being



reduced. The amount of Minamiboso's "Town Merger Compensation" for 2013 was ¥3.7 billion, which comprised about 15% of the city's total revenue for that year.

# The Funding from the Town Merger Compensation will be Cut Gradually, Ending Completely in 2021

Allocated tax money, which makes up 40% of Minamiboso's yearly revenues and is vital to the city, will be cut gradually from 2016 to 2021. It is projected to be lowered to  $\pm$ 7.6 billion by 2021, <u>a</u> <u>reduction of  $\pm$ 2.5 billion</u> from the current amount.



\*In previous publications on the

city budget, the decrease in revenue with the loss of the Town Merger Compensation was said to be ¥4.0 billion. However, under the 2014 revision of the tax allocation system, the "taxation calculation reflecting the expansion of administrative zones due to city, town and village mergers" policy was established in hopes of reducing the scale of cutbacks.

#### Preparing for the End of Town Merger Compensation

In preparation against unexpected expenses and reduced revenues, Minamiboso has a "Public Finance Adjustment Reserve" comprised of money from years in which there were excess funds. The balance of the reserve was ¥7 billion as of the end of the 2013 fiscal year.

However, if the city tries to use the reserve to balance its budget without reducing yearly spending proportionally to the decrease in the temporary Town Merger Compensation, <u>the city will run a</u> <u>deficit within 10 years.</u>

If this happens, Minamiboso will have difficulty paying for even the most minimal management of public institutions and basic public services. The city will then have no choice but to dramatically increase public utility and administrative fees.

#### We Must Prepare for a Large Decrease in Revenue in the Near Future

We must be diligent in further reducing expenses in order to balance the city budget. Looking at Minamiboso as a singular city with a population 40,000, there are too many public servants, schools, preschools, daycares, local branch offices, and various other public institutions. This is because most of those facilities remain from when the city was 7 separate towns and villages.

The city will have to speed up its current efforts in administrative and financial reform, beginning by reducing personnel and mandatory expenses. From now on, it will also be necessary to reduce various subsidies and grants, restructure sports and sight-seeing events, integrate and close down public institutions, and reevaluate utility costs, administrative fees, and requirements for tax exemptions.

# Special Collection of Individual Inhabitant Tax

#### What is Individual Inhabitant Tax?

It is a locality tax comprised of both city and prefectural taxes.

#### What is the Special Collection?

Employers will be responsible for deducting Individual Inhabitant Tax from their employees monthly pay. That tax money then goes to the local city, town, or village government.

#### Who will have this Tax Deducted from their Pay?

In principle, every laborer who is subject to income tax (including part-timers, executives, etc.) will have the Individual Inhabitant Tax deducted from their pay, regardless of whether the employer is an individual or a corporation. Bills for the Individual Inhabitant Tax will no longer be sent out by City Hall.

#### Starting in 2016

All Individual Inhabitant Tax in Chiba Prefecture will be collected through the new pay deduction system as of 2016. Everyone who still receives a bill for this tax from their municipality will be transferred to the new payment system as of June 2016.

Furthermore, in some cases it is possible to start the Special Collection early. If possible, it is recommended to switch to this new system in 2015.

#### Exceptions

If one of the following applies to you, you may remain under the Normal Collection system instead.

- 1. You work for family.
- 2. You are not paid monthly.
- 3. Your monthly pay is too low for the Special Collection to be deducted from it.
- 4. You have retired or plan to retire by May 31 of the year in which you report your income.
- 5. Your Individual Income Tax is being deducted from a separate pay check.
- 6. You are an employer with two or fewer employees. (An employee in this case includes all employees who do not apply to numbers 1 through 5 above.)

#### Survey

A survey regarding the switch to the Special Collection system will be mailed out in November. The questionnaire will gauge awareness of the new system and allow citizens to express questions and concerns. Further information will be published in response to the survey at a later date.



### **Paying Taxes by Bank Transfer**

#### Convenience and Peace of Mind: Paying City Tax by Bank Transfer

Have you ever missed the deadline to pay your taxes and had to pay late?

If so, you may have been charged late fees, been sent warning letters demanding payment, or had wages garnished as a penalty.

To avoid these issues, you can set up a transfer from your bank account. Just register your account and taxes will be automatically withdrawn on the day they are due, saving you the trouble of going to the city office. Next year's taxes will also be withdrawn automatically, so you will not have to worry about when to pay them next.

#### **Registration is Simple**

Applications can be filled out at financial institutions in town. If your financial institution is outside of Minamiboso, please



file a "Request for Bank

Account Transfer" to the division in charge of the particular tax you would like to pay.

The taxes that can be paid by bank transfer include: Municipal and Prefectural Resident Tax, Property Tax, Light Automobile Tax, National Health Insurance Tax, Elderly Medical Insurance Fees, etc. If you co-own property, each individual must apply separately to pay their share of property tax.

It takes some time to process the application, so please register at least 2 months prior to the tax payment due date.

#### Insufficient Balance

Please note that if your account balance is too low, the transfer cannot occur. To insure payment, make sure the balance is high enough for the transfer to go through.

If the transfer does not go through, please pay directly at a city office as soon as possible (this can be the main office, local branch office, or Asai Administration Centre).

If you will be paying directly at your financial institution, you must have a tax payment form. Please contact us to have a form sent to you. You may also use the payment form attached to a Notice of Demand for Tax Payment.

#### A School for Building an Educational Foundation

Preschool is for young children, ages 3 to 5, to prepare them for elementary school. When a child turns 3, their interest in and relationships with others develop rapidly. The 4-hour days at preschool serve as a foundation for further education and help children develop individuality and social skills.

#### **Eligible Children**

Children enrolled in preschool who meet one of the following conditions

- 1. Their parents or guardians work during the day and cannot find a suitable baby sitter.
- 2. Their guardian or family member is ill and/ or requires nursing care and cannot find a suitable baby sitter.

\*When the daycare's capacity is reached, admission will be reviewed. This is not based on the order in which families applied.

\*Families with children who are already attending and wish to keep attending must reapply each year.

#### How to Apply

Bring the application form, your personal seal, and necessary documents. The form and documents are available at the Childhood Education Division and each daycare facility.

#### **Necessary Documents**

- Profile Sheet: This is necessary for the daycare staff to understand your child's

needs and special circumstances (such as allergies).

# Staying Healthy

#### **Encouraging Good Behavior**

It is often said that you should raise children by praising them. But is it really so easy to do? Being busy with housework and bringing up a child, it is easy to lose sight of the good things your child does and only see the bad. You may notice yourself getting irritated, scolding them a lot, and having less and less good behavior to praise

#### • What is "Praise?"

"Praising" a child is showing positivity and telling them they are being good. Doing this reinforces good behavior, giving them direction and helping them grow.

#### Being Praised Leads to Growth

Even adults are happy to receive praise. It gives us motivation.

When a child receives praise from an adult, it changes their behavior and attitude, encouraging them to grow.

By praising good behavior rather than scolding bad behavior, a parent can change their child's habits for the better.

#### • What to Praise?

It is important to praise even behavior that seems ordinary to adults, not just big improvements. It is a good experience for a child when their family, who they love, recognizes their efforts and accomplishments. This recognition gives them the will to succeed.

#### · How to Praise

Whenever you think "that's great," "they did a good job," or "I'd like them to do that more," express this to your child immediately, either through words or a gesture.

Don't just keep your thoughts to yourself, but tell them "you did that well." Also try adding a "thank you" to further express your appreciation.

#### Keys to Praise

#### 1. Praise any accomplishment

Keep an eye on what your child does from day to day. There are things to praise even in ordinary activities they do all the time. If you think you would like them to keep doing something, then encourage it.

#### 2. Show your feelings

Make eye contact and put some feeling into your praise. Pat them on the head or hug them. Physical gestures are also effective for encouragement.

#### 3. Be specific

Avoid just saying things like "That was good." Let them know exactly what part of their behavior you like. For example: "I'm so proud of the way you greet people so energetically!"

#### 4. Show you are thankful

When your child does something for you, tell them "Thank you. You really helped out!" If you show them you are happy to receive help, they will want to continue being helpful.

#### 5. Do it right away

Praise good behavior as soon as you notice it. Make sure to do it in the moment as much as possible.

#### 6. Praise the process, not just the results

Even if the result was not good, or even if it was disappointing, make sure to praise the effort they put in. This will encourage them to keep trying.

### 7. Personal growth is important, not comparisons to other children.

Instead of making comparisons to others, praise your child's personal growth, no matter how small. If you praise actions that they chose to do on their own, it will encourage them to keep trying things in the future.

#### 8. Keep it up in the future

Children always want to be noticed. Praise good behavior even if you just said something nice about the same thing the day before.



# The New Childcare Support System

Three new childcare laws were adopted in August 2012. The purpose of these laws is to create a society where every child can grow up healthy. The "New Childcare System" established under these laws will go into effect in April 2015. Under the new system, local municipalities will focus on providing various kinds of support to households raising children.

#### What will change under the new system?

#### Comprehensive Education and Childcare

Municipalities will create facilities and systems that allow children to receive quality care and education while their parents are working.

**Education and Care Facilities** 

#### Preschool (Ages 3-5):

1

Children attend preschools from ages 3 to 5, before starting elementary school. Preschool teaches with a focus on playing and serves as a foundation for later education.

#### Nursery School (Ages 0-5):

Nursery Schools take care of babies and young children whose parents are unable to look after them during the day, usually because they work.

#### 3 Criteria

Three criteria are used to determine whether a child should attend preschool or daycare. (\*This is not significantly different from current practices.)

Family Situation	Criteria Category	Eligible For
3 and up, preschool education desired	#1 (Full-time Education Criteria)	Preschool
3 and up, meets requirements for nursery school, nursery school desired	#2 (3-and-up Nursery School Criteria)	Nursery School
Under 3, meets requirements for nursery school, nursery school desired	#3 (Under-3 Nursery School Criteria)	Nursery School

Concerning Nursery School Criteria (#2 and #3)

1. There are other requirements for enrollment at a nursery schools. These include: work, pregnancy and giving birth, sickness/ disability of guardian, nursing care for or looking after a family member, disaster recovery, job-hunting, taking classes, fear of abuse or domestic violence, continuing childcare services from before, and other similar situations recognized by the local government.

- 2. Childcare during work is divided into two categories.
  - A. Full-time care: Must have a full-time job (maximum 11 hours of care per day)
  - B. Part-time care: Must have a part-time job (maximum 8 hours of care per day)

### 3

#### Improving Local Childcare Support

Childcare services will be improved on the local level. Additional childcare support facilities will be built and more services will be provided that support all families raising children. These include: after-school care, care for children recovering from sicknesses, local childcare support centers, family support centers, etc. \*Further information will be published in the Announcements newsletter and on the city website.

Q: How much will daycare cost?	A: Using the standard set by the national government as a maximum, the city will determine fees based on current levels of financial burden and family income.
Q: Will support for families raising children at home increase too?	A: Yes, the new system will create places where parents and children can get help and participate in activities close to home, not just schools.
Q: Under the new system, will city-run preschools also start at age 3?	A: No, city preschools start at age 4 and can be attended for 2 years.

### Subsidy for Home Energy-Saving Equipment Installation

To optimize and increase the efficiency of household energy and fight global warming, the city has been giving subsidies for home solar panel system installation since July. But as of October 1, installation subsidies are also available for the following home energy-saving systems.

#### Equipment Covered:

- Home solar power systems
- Home fuel cell systems (ENE-FARM)
- (installed after July 1)
- (Installed after October 1)
- Stationary lithium ion energy storage systems (Installed after October 1)
- Energy management systems (HEMS)
  Electric car charging systems

(Installed after October 1) (Installed after October 1)

- Application Deadline: January 15, 2015 (\* Or when the budget has run out.)
- Equipment Eligibility:
- Must be an unused item
- · Other than solar power systems, must be approved under the national subsidy project
- For solar power systems, quality and performance must be certified by the Japan Electrical Safety and Environment Technology Laboratories (JET).
- For solar power systems, the maximum power output of the solar battery module must be less than 10 kilowatts.
- Amount of subsidy: (Fractions of less than ¥1,000 are rounded down.)
- Solar power systems- ¥70.000 Maximum (¥20,000 per 1 kW maximum output)
  - [Example] 1 panel produces 240 watts (0.24 kilowatts) and you have 16 panels installed.
     The maximum power output is: 0.24 kilowatts × 16 panels = 3.84 kilowatts (decimals of the third digit and below are rounded up)

**The Subsidy Calculation is:** ¥20,000 × 3.84 kilowatts = ¥76,800 Therefore the subsidy would be the maximum of ¥70,000

- Home fuel cell systems (ENE-FARM)- ¥100,000 maximum
- Stationary lithium ion energy storage systems- ¥100,000 maximum
- Energy management systems (HEMS)- ¥10,000 maximum
- Electric car charging systems- ¥50,000 maximum
- To be eligible, you must:
- Have an address in Minamiboso City now, or by the time you submit the Report of Results form.
- Live in or plan to live in the house that will have the equipment installed. This must be a free-standing house (homes also used as stores are included).
- When installing a solar power system, have entered into a contract to receive electricity from a power company before submitting the Report of Results form.
- Have no outstanding city taxes.

#### To Apply:

- 1. Fill out the application form and submit it to the Environmental Preservation Division.
- 2. Once your documents have been reviewed, you will be sent a Notification of Subsidy Amount.
- 3. After installing the system, submit the Report of Results form and necessary documents to the Environmental Preservation Division within 30 days (or before March 2, 2015, whichever is sooner).
- 4. Once your documents have been reviewed, you will receive a Final Decision Notification.
- 5. After receiving the Final Decision Notification, submit the Request for Subsidy form to the Environmental Preservation Division.

# Submit the application form and wait to receive the Notification of Subsidy Amount before starting construction.

### The Winners of the 6th "Cooking with Local Ingredients in Minamiboso" Contest

The final round of the contest, with the theme of "hamburgers made from Minamiboso's local ingredients," was held on October 19 at the Miyoshi Rural Community Improvement Center. This contest, part of the city's program for the consumption of local produce, was open to Minamiboso elementary and middle school students. Including both the individual and group divisions, there were 326 dishes submitted by competitors.

A panel of seven judges who work in the food and commerce industries selected 10 top competitors. Afterwards, a winner was selected from those 10 by a taste test open to the public.

The winner of the Grand Prize was Hikaru Itou, a 2nd-year student at Chikura Middle School, whose "sunflower burger" incorporated the bounty of the plants and the sea of Minamiboso. This hamburger won praise for its combination of flavors and inspired use of seasoning. The judges' comments included: "The flavors are subtle, but the ginger really works. This is Delicious." and "The color and sweetness of corn are a nice touch."

In addition to the Grand Prize, there were three Awards for Excellence and six Judges' Choice Awards. Another two awards were given by the Chikura Association of Cooking and Eateries.

According to the judges, it was hard to choose which dishes to give awards to because each dish showed such individuality and inventiveness.

Winning recipes will continue to be published in future newsletters. We are also looking for people who could market and sell the winning dishes.

#### Ingredients (makes 4 servings):

Hamburger: 400g ground meat (chicken thigh), 2 *sazae* (turban shell mollusk), 10g *hijiki*, 10g chives, 10g ginger, 2 goya, 20 grape tomatoes, 2 eggplants, 1 ear of corn Sauce: soy sauce, sugar, potato starch

#### **Directions:**

- 1. Knead together ground meat, *sake* steamed and diced *sazae*, boiled and diced *hijiki*, chives, and ginger. Divide into 4 patties and grill both sides.
- 2. Cut goya into rings and remove seeds. Cook along with eggplant.
- 3. Boil corn in salted water then cut from cob.

-Putting Vacant Houses to Good Use-

Akiya Bank is an organization that links the city and people who may want to move to Minamiboso. It encourages people to move here while also promoting the use of currently vacant houses.

If you would like to sell or rent out a residence that is currently uninhabited or will be uninhabited in the near future, please register it with Akiya Bank. (Please note that Akiya Bank does not register houses for sale or rent by private businesses.)

The application form is available on the Akiya Bank website and through the Planning and Policy Division.

Buildings will be inspected shortly after the application has been received. If a building meets certain requirements, it will be registered with Akiya Bank.

Information on registered buildings is made available to people interested in moving to Minamiboso through the Akiya Bank website.

(To learn about the requirements for registration, please contact Akiya Bank.)

Registration is also required for people who want to use Akiya Bank's services to find a place to live.

# Renovation Subsidies for Owners of Vacant Rental Properties

Akiya Bank will pay up to 2/3 of eligible renovation expenses (with a maximum of  $\pm 2,000,000$ ) for vacant rental properties. This applies to cases where a property owner has signed a rental contract with a new tenant.

Renovation work will be done by a contractor from a partner company.

Renovated buildings are required to be registered with Akiya Bank for 10 years and must be rented to people moving to Minamiboso from other locations.

#### Eligibility

- The renovation work must increase the functionality of the property. Supply costs and types of construction must also be approved by the city.
- The cost of the work must be over ¥500,000 before tax.

- You must not be receiving other aid from the country, prefecture, or city.
- Renovation work must be completed by March 31 of the fiscal year in which the application is filed.

### **Continuing Education Loans**

Whether it is to start a business or to find a new job, educational loans are available to people enrolled in professional skills development programs.

**Amount of Loan:** Up to ¥60,000 per month **Lending Period:** From 6 months to 3 years **Repayment Period:** Up to twice the length of the lending period

**Guarantors Required:** 2 (1 must be a property-owning Minamiboso citizen.)

**Required Documents:** Application form, written oath, guarantor form, guarantor's registered seal, proof of enrollment

#### Eligible Schools:

- Universities, graduate schools, junior colleges, special vocational schools, and vocational schools approved by the School Education Act (must meet the standards set by the Cabinet Minister)
- Fisheries schools, maritime technology institutions, and aviation schools (independently administered institutions)
- Vocational schools, junior colleges, universities, and centers for professional skills development.
- Educational institutions that are certified by the head of a national administrative body or a prefectural governor.
- Educational institutions within the country that are run according to the educational standards set by the Cabinet Minister.

### Requirements for Exemption from Repayment:

- A Minamiboso citizen who starts a business within the city (business must operate for at least one year) = Complete exemption
- A Minamiboso citizen becomes reemployed. (Comes into effect once length of employment equals length of lending period.)
   = Exemption from 1/2 of loan repayment

#### **Farmer's Pension**

To prepare for retirement, farmers can put money into a Farmer's Pension. The amount of the pension is determined by how much money has been put in the account. There is ordinary enrollment and policy support enrollment.

Pension premiums are eligible for a deduction of the entire value of social insurance premiums, and the pension paid to you is applied to your public pension deduction.

#### **Enrollment Requirements:**

Anyone between the ages of 20 and 60 who is enrolled in the National Pension Plan and engages in agricultural work 60 days or more a year may enroll. Spouses, successors, and family members engaging in farm work may enroll as well.

Please note, you must also be enrolled in the National Value-Added Pension Plan (¥400 per month).

#### Premium:

You may choose any amount between ¥20,000 and ¥67,000 per month (in multiples of ¥1,000). This amount can be changed at any time.

#### How to Apply:

Please apply to the Agricultural Committee Secretariat or a JA Awa branch.

#### **Receiving Payments:**

Retirees generally start receiving pension payments at the age of 65. You can also request the payments start from the age of 60.

# Government Subsidies for Premium Payments (Policy Support):

Registered agricultural workers who submit a blue return and meet some other requirements are eligible to receive a subsidy of up to  $\pm 10,000$  for every  $\pm 20,000$  of their monthly premium (overall maximum for the subsidy is  $\pm 2,160,000$ ).

A special additional pension is also available in cases of inheritance of farm land.

# [Requirements for Enrollment in Policy Support]:

- 1. Anticipate to pay a pension premium for at least 20 years by the age of 65.
- Income from agricultural business (Or, if you are the spouse or successor of the farm owner, the payment you have received) must be ¥9,000,000 or less after taxes.



#### Mr. Kinji Ikuina Receives Local Education Administration Award



### Be Careful of Nursing Home Scams

There has been a recent increase in scams related to moving into elderly care nursing homes. Using clever tricks, the scammers convince their victims that space in nursing homes is limited. They then ask them to give money so that others can have the ability to move into a nursing home, pretending they are providing a charity service.

Taking advantage of the kindness and compassion of the elderly, these scammers prey on the fact that problems in nursing homes are near to their victim's hearts.

# [Example Situation] Only people with move-in permission forms can apply?!

Several days ago, a pamphlet and a move-in permission form for a nursing home that will be completed next spring arrived in the mail. Today, you receive a phone call from a separate company. They tell you, "We have 6 or 7 people who want to live in the nursing home, but they won't take applications from a business. Only people with a move-in permission form can apply. The nursing home has a good reputation, so it may fill up. So we don't bother the nursing home, we want you to ask if they still have space for us." Because you thought you were helping people, you made a call to the nursing home.

#### There are Four Major Types of Child Abuse


- 1. Giving a child a physical wound, or acting violently toward a child in a way that may cause a wound
- 2. Molesting or committing a lewd act on a child, or making a child commit a sexual act on oneself
- 3. Preventing a child's mental or physical development through neglect such as not giving them enough food or leaving them alone for long periods of time
- 4. Causing considerable psychological trauma through verbal abuse

# November is "Preventing Danger from Animals Month"

Take the following precautions to avoid accidents and trouble with animals.

#### Attention All Pet Owners:

- O Letting dogs run free in public spaces like parks and beaches is prohibited. When taking your dog on a walk, keep it under control with a short leash.
- Tie up your dog in a place where it cannot reach visitors to your home. Also make sure to regularly replace metal fittings and chains.
- The uncontrolled breeding of cats has become a problem across Japan. If you do not want your cats to breed, please have them spayed or neutered. This can also be a solution to other problems cats have when breeding, such as getting sick or injured from fighting or wandering away from home.

#### Be Responsible and Care for Your Pets.

If for unavoidable reasons you become unable to care for a pet, please find a new owner. Healthcare and Animal Protection Centers can help with finding someone.

- O Never abandon an animal. There are severe legal penalties for doing so. It is also a major nuisance to the people who live in areas where animals are abandoned.
- O It is very important to train the animal in such a way that it will not cause an accident or be a nuisance. The Awa Health and Welfare Center consults pet owners on how to train and take care of their pets. Please contact us with questions.

#### Sightseeing Streetlights to be Replaced by Crime Prevention Lights

There are about 1700 "sightseeing streetlights" around the city. In shapes such as *biwa* fruit,



daffodils, rape blossoms and tulips, these lights were made when the towns and villages of Minamiboso were separate. Because they are old and out of date, maintenance on the streetlights costs about ¥20 million each year. As a result, each of these fixtures will be replaced with an LED crime prevention light, all of which will be maintained under the same system. Giving consideration to management costs, most of the newly-installed lights will be installed as part of a multipurpose telephone pole.

The sightseeing lights will be retired next year. They will no longer light up, but the fixtures will remain as decorations.

#### **About Generic Drugs**

Generic drugs are drugs that are released on the market after the original, brand name drug's patent has run out. Generic drugs have the same active ingredients as the brand name ones they are based on.

Generics are usually less expensive, decreasing the financial burden of medical expenses on the patient, as well as financially benefitting health insurance providers.

Because of this, notifications are sent to those enrolled in National Health Insurance stating how much their current prescription costs would decrease if they were to switch to a generic equivalent. (These notices are aimed towards people taking prescription drugs for adult onset diseases and chronic conditions.)

\*The notice is only meant to inform people of the lower prices of generic prescriptions. There is no obligation to switch drugs.

# About Assistance Getting to an Evacuation Center During a Disaster

"Assistance in getting to evacuation centers in times of disaster" is a system that helps the elderly, disabled persons, and anyone who may have difficulty getting to an evacuation center quickly after a natural disaster occurs. The people who need assistance register with the system, then their neighbors are notified that they must assist them in case of a disaster.

Registration forms have been distributed to members of the target group for this program. Anyone who has not received the form but would like to register, and those who have registered but no longer need the service, please contact the Social Welfare Division.

#### Eligibility:

People in the following living situations are eligible to register.

O People 75 or older and living alone

- O Households where everyone is 75 or older
- O People needing nursing care
- O People who have a physical disability notebook of level 1 or 2, a rehabilitation notebook of level A or A, or a mental disability health and welfare notebook of level 1.
- People who need assistance but do not meet the above requirements

\*People who are hospitalized are not eligible.

#### The Citizen Judge System: List of Candidates will be Released Soon Choosing the Jurors

The list of candidates for juries are determined by a random lottery performed by the Election Management Committee. These lists are made at all local courthouses across the country.

#### **Jury Candidate Notifications**

Those who have been selected as jury candidates for 2015 will receive a notification to that effect in mid-November of this year. Recipients of the notification are asked to come to a courthouse between February 2015 and February 2016, when they may be selected as a juror. Jury duty information is given in advance so that jurors may mentally prepare.

In this process, jury candidates are not chosen for specific cases, so it is not necessary to come to the courthouse right away.

A questionnaire will come with the notification. The answers given on this questionnaire let the court understand the candidate's situation for the following year without making them come in person to the courthouse. It is meant to lessen the burden on the jury candidate.

#### Prefectural Welfare Seminar: Making Our Region Strong Against Natural Disasters

When a disaster strikes, people must confront many different types of crises. The Tomiyama Kendo Association is an organization that cultivates character through the founding principles of kendo and fosters good mental and physical health in youth. Made up of kendo lovers, the group also aims to spread knowledge of the sport throughout the area.

Last year, the Tomiyama Middle School Girls Team won the team championship at the Chiba Prefecture Middle School Athletic Tournament and went on to compete at the national competition. This year they placed 3rd in the prefecture. Kendo has always



been popular in Tomiyama and many of the members of the club started at a young age.

The Tomiyama Kendo Association's biggest event is the Chiba Prefecture Elementary and Middle School Kendo Tournament, "Competition for the Fusehime Pennant." This tournament was originally hosted in Old Tomiura Village, but with the merging of Minamiboso, there were concerns about whether it would continue taking place. But Tomiyama's flame of passion for kendo is inextinguishable; the tournament continues today and is hosted by the Tomiyama Kendo Association.

Once the tournament was over, the participants were both exhausted and felt an indescribable sense of fulfillment.
