#### Filing Returns and Making Payments

The filing period is February 16 to March 16. During this time, the Tateyama Tax Office will be extremely busy. Please feel free to bring in your return on or before February 13 to avoid the rush.

Please affix the required documents to the your tax return form and submit them together. The tax office will not accept returns on Saturdays, Sundays or holidays, but you can fill out your return through e-Tax (the national electronic tax return filing and payment system) and submit it by mail or by leaving it in the tax office's drop box.

Because the filing period is very busy, please fill out your return on your own and submit it as early as possible.

# **Changes to Individual Resident Tax in 2015**



### Expansion and Extension of Special Deductions for Renters

The special tax deduction for housing rental established under the 2013 revised tax code will be extended to December 31, 2017 and the amount of the deduction for rentals started in and after April 2014 will be increased. This is applicable to income tax for 2014 and after, and to individual resident tax for 2015 and after.

#### ■No More Reduced Tax Rates for Stock Market Transfer and Dividend Income

1. End to the special measures to reduce tax rates for stock market transfers

Taxes on income from stock transfers were reduced to 10% (7% income tax, 3% individual resident tax) between January 1, 2009 and December 31, 2012. The special measure that did so was discontinued on January 1, 2014.

As of January 1, 2014, taxation has been 20% (15% income tax, 5% individual resident tax) as prescribed by the tax code. This is the amount you will be taxed this year for your 2014 return. \*2.1% of income tax paid from 2013 to 2037 will be applied to special income tax for reconstruction.

2. End to the special measures to reduce tax rates for stock market dividend income

The reduced 10% tax rate for dividend income has been discontinued. Details are the same as for stock transfer income above.

# ■Rules for Tax-Free Accounts with Low Income from Stock Market Transfers and Dividends

Tax-free accounts opened with financial instruments business operators from 2014 to 2023 have a yearly new investment limit of 1 million yen and must receive payments from stock transfers and dividends within 5 years to remain tax-free.

### **Enrollment Fees for Nursery School and Preschool**

#### ■Fees are Determined by Income

Fees vary by school, the child's age as of April 1, 2015, and the legal guardians' municipal income tax for 2014. (Fees for September onward will be recalculated using 2015 municipal tax.) In general, fees are determined by parents' income, but if a child is dependent on the income of a grandparent or other family member, fees will be calculated from their municipal income tax.



- You may estimate fees yourself using your 2014 city or prefectural tax returns.

#### Paying Fees

- Please pay fees by transferring money from a bank account.
- If you cannot pay by account transfer, use the payment slip you were mailed to pay at a financial institution or the city office.



- Fill out the appropriate paperwork at one of the institutions listed below.
- Once you have applied, it will take 1 to 2 months for the automated withdrawals to start. Until then, please pay using the payment slip.

### **Registering for Cancer Screenings**

When you attend a city cancer screening, you will be registered for the following year as well. You will be notified of your next screening by mail. You do not need to reapply each year. However, if you do not attend your scheduled examination for two years consecutively, your registration will be cancelled and you will no longer receive notices. If your registration is cancelled but you wish to be examined again, you must reapply.

### **Examinations that use this registration system:**

Tuberculosis and lung cancer, stomach cancer, prostate cancer, colon cancer, breast cancer **Getting an Examination:** 

Anyone registered as a Minamiboso citizen and of the target age for a particular exam is eligible, regardless of insurance.

#### **How to Apply for 2015 Screening:**

1. Those who are the appropriate age for a screening (see the following table) will be

- mailed a registration form in late January. If you wish to get the examination, submit the form by the deadline.
- 2. Those who were examined in 2013 or 2014 will be sent an exam notice. There is no need to apply.
- Those who want to get a screening but do not fall in categories 1 and 2 can apply by phone.
- \*To check on your registration status or make changes to an application, contact the Health Support Division.

## \*Examinations not using this registration system:

Adult dental exams, osteoporosis, hepatitis

# Minamiboso's 'Local Care Association' Project

### Community Support for People with Dementia

There are 4.62 million people in Japan living with dementia. If you include the 4 million with mild cognitive impairment (MCI), there are 8.62 million. The days of only treating patients with cognitive impairment at hospitals and health centers are over.

But we are also losing the capacity for families to care for their own aging relatives. It is now ordinary for elderly people with dementia to live alone and for people with dementia to be cared for by loved ones who have cognitive impairment themselves.

This is why there is a need for communities to take care of elderly people with dementia.

But are communities up to the task? With the aging of the population, there are fewer and fewer suitable candidates to lead local groups to support the elderly. There are probably many of these groups that have disappeared as a result.

Japan's population has aged to an unprecedented extent and we are struggling to come up with a way to fix it. It would be no exaggeration to say that the Awa region is at the forefront of this fight.

#### [We must create a new system]

Each region needs to create it's own system. The country is having financial trouble and there are not enough young people to care for the elderly.

The policy the national government decided on was the enigmatic phrase:

"creation of regional comprehensive care systems."

My own interpretation of what the government is saying is: "Japan is out of money, so each individual area has to find its own way to make do."

### [Minamiboso City's Local Care Association (Local Care Team)]

In response, Minamiboso created the "Local Care Association (Local Care Team)." Since July 2012, experts in the field of elderly care have joined the team, creating much lively discourse.

Here are some of the big accomplishments the team has made in these two years.

- 1. Drafted an agreement between the city and facilities to create welfare evacuation sites (emergency evacuation sites for older people who are in poor health)
- 2. Established the "Minamiboso Disaster Support Group" among welfare evacuation facilities
- Created and distributed questionnaires on the welfare evacuation sites' handling of the Great East Japan Earthquake
- Started project to create a network to look after people with dementia (elementary school students making stickers for cooperating facilities, etc.)
- 5. Training supporters for the cognitively impaired

The mantra of the Local Care Association is: "Over 1000 ideals. One result to help the elderly." I think that this group will continue to do good work into the future.

### [It's time for everyone to think of something they can do for the community]

The city is trying to decide on its method for elderly care. This means Minamiboso will be asking its citizens to come up with creative solutions.

But in a way, this is dangerous. That danger is called the "city, town and village gap," meaning that results will vary based on a town's finances.

On the other hand, the scary thing would be conflict between the people of Minamiboso. People often say, "What can the city/ prefecture/ country do?"

A famous politician once said, "Ask not what your country can do for you. Ask what you can do for your country." I think that now, in this "regional era," that each individual has to consider what they can do for their city.

#### [Let me decide what's best for me]

The people tasked to think about what to do for the community must of course also include those with cognitive impairments. Clearly, when making decisions that effect the disabled, the disabled people themselves must have a say in the matter.

Early-onset cognitive impairment has become a central topic in the media and we are all aware that cognitive impairment could affect any of us. I believe that we are in the age of making choices for ourselves.

### Certificates for Medical Cost Tax Deductions: Adult Diapers and Disability

You must apply for certification every year. Please apply at the Health Support Division, Citizenship Division, Asai Administration Center, or any branch office. The certificate will arrive in the mail about one month after application.

### **Deduction for Cost of Medical Adult Diapers**

#### Eligibility:

To receive the deduction for more than 2 years, you must be certified as needing nursing care, and be able to confirm you are

confined to bed and incontinent with nursing documentation.

\*To receive the deduction for the first time, you must receive a "a certificate of diaper use" from a doctor rather than getting this certificate.

#### **Disability Deduction**

#### **Eligibility:**

To receive the deduction, you must be over 65 years of age, not have a physical disability notebook, mental disability health and welfare notebook, or rehabilitation notebook. You must also have certification stating you require nursing care from level 1 to 5 or be confined to bed.

# Investments Guaranteed to Turn a Profit?

Financial troubles related to stocks or mutual funds have some unique characteristics that make them hard to resolve.

Of course there are some financial systems that are fair and transparent as well as some that have established social standing. Consumers who understand and choose to invest in those systems typically do not have many problems.

However, there are investment firms that cause trouble by repeatedly sending junk mail promising a profit and confusing consumers with complicated schemes.

When someone runs into trouble with that kind of firm, it is not uncommon for the problem to be very difficult to resolve, even for a specialist.

The fact is, there are no investment opportunities guaranteed to turn a profit. The

words "guaranteed profit" should make you suspicious. If you get a phone call along those lines, hang up immediately and contact the Consumer Consultation Center.

## Emergency Broadcasts Will Change starting this April

The installation of the digital wireless emergency broadcast system will be completed in March, bringing digital disaster information broadcasts to every area in Minamiboso.

These wireless broadcasts will change in the following ways.

### 1. Fires will only be announced in the town or village where they occur.

Currently when a fire occurs, it is announced across all of Minamiboso, but starting in April, they will only be announced in the area affected. Announcements will be broadcast on outdoor speakers and household receivers.

### 2. Fixed-time broadcasts will only be played on household receivers.

There will be regular announcements from the city broadcast at 7:15 AM and 7:15 PM to household receivers. They will not be broadcast on outdoor speakers.

(Fire and emergency alerts will continue to be played on outdoor speakers.)

\*Some people were not given a household receiver because they live near an outdoor speaker. If you are in this situation and want to get a receiver, please contact the Fire and Disaster Prevention Division.

#### 3. Test Broadcast Songs and Chimes

Each town currently plays different songs, but they will be the same across Minamiboso starting in April.

#### **Dumping Garbage is a Crime**

The illegal dumping of garbage at roadsides, in forests and mountains, and other places out of the public view is showing no significant decline. This kind of littering is more than just an eyesore. It is bad for the environment because it can cause bad odors and pollution to water and soil.

What is Illegal Dumping?

Illegal dumping consists of throwing away or burying waste in fields, forests and on mountains. It is an act done without regard for others, and is in direct opposition to garbage disposal laws.

#### For example:

- Loading waste into a truck and throwing it away on an unpopular mountain
- Piling up garbage in a natural area and leaving it there
- Using a dump truck or other heavy machinery to bury waste on vacant land
- Leaving sulfuric acid or other harmful waste in an empty warehouse or disused factory
- Throwing cigarette butts, empty cans, and other litter on the road side

#### **Punishment**

Those who have committed the crime of illegal dumping will serve up to 5 years in prison, pay a fine of up to ¥10,000,000 (up to ¥300,000,000 for organizations and companies), or both.

There were also funds added to local workers' pay, as well as heating, lighting, and water costs, etc.


#### **Honobono Christmas Party**

### Minamiboso's Ten Biggest Stories of 2014

A lot happened in 2014. Here are Minamiboso's top ten news stories from 2014 as chosen by government employees.

1	Reinan Middle School and Chikura Elementary School were opened. (April) Wada and Maruyama Middle Schools merged to create Reinan Middle School and Nanaura, Kotto, Asai, and Takeda Elementary Schools merged to create Chikura Elementary.
2	The mayoral and city council elections (April) Mayor Ishii ran unopposed and was elected for his third consecutive term. 20 council members were elected to the city council.
3	Miyoshi Kodomo-en combined preschool and nursery school opened. (September) Miyoshi preschool and nursery school combined to create the first facility of its type in the city. It was opened to counter issues created by the low birth rate. The combined school lets children socialize in larger groups.
4	The 100th Biwa Selection (June) Tomiura has presented biwa fruit to the imperial family since the 42nd year of the Meiji period. This year, the ceremony to select fruit for the tribute was held for the 100th time.
5	The 9 City and Prefecture Combined Disaster Prevention Practice was held in Minamiboso. (September)  Saitama Prefecture, Tokyo, Chiba Prefecture, Kanagawa Prefecture, Yokohama, Kawasaki, Chiba City, Saitama City, and Sagamihara City held a combined disaster prevention practice at the Wada Local Welfare Center.  The Self Defense Force, Coastguard, fire and police departments, and other disaster relief and prevention groups participated.
6	Typhoons 18 and 19 hit the city. (October) Typhoons pounded Minamiboso for two weeks straight, causing heavy damage to crops and all across town.
7	The Tomiyama Elementary and Preschool PTA won the Chiba Prefecture PTA Volleyball Tournament (October) The Tomiyama PTA, having won the Awa Regional tournament three years in a row, achieved their dream of victory at the prefectural PTA volleyball tournament. Tomiyama is the first team from Awa to win the championship since the tournament started in 1976.
8	The "Most delicious school lunches in Japan" Program was started. (September)  To create locally-sourced school lunches, the city has started registering farms and vendors who provide food and ingredients to Minamiboso's schools. Farmers who meet the city's requirements are given a certificate and seal while vendors are given a certificate and sticker.
9	3 Roadside Stations in Minamiboso Recognized with "Kanto Michi no Eki Awards." (September) Tomiura Biwa Club, Furari Tomiyama, and Wadaura Wa-O! were ranked in the top 30 roadside stations out of the 149 "michi no eki" in the the greater Kanto region.
10	Inviting Companies to Minamiboso (January) The city is inviting companies to locate here to encourage local economic growth. The first such agreement has been made with an IT company.
